NURSERY STOCK DEFINITION

All trees, shrubs, plants and vines and parts thereof.

GENERAL SHIPPING REQUIREMENTS

Any nursery stock shipped into New York must have an unexpired inspection certificate, issued by an authorized official from the state of origin attached to each package signifying that the contents appear to be free from all injurious plant pests. Addresses of the consignor and the consignee shall be included along with a list of varieties of nursery stock and a statement that the contents are alive and vigorous.

NOXIOUS WEEDS

The introduction of noxious weeds is prohibited; referring to any living stage of any parasitic or other plant of a kind which is of foreign origin, is new to or not widely prevalent, and can directly or indirectly injure crops, other useful plants, livestock or poultry or other interest of agriculture.

QUARANTINES OR ADDITIONAL REQUIREMENTS

GRAPE VIRUS QUARANTINE

PEST: Fanleaf, Leaf Roll, Corky Bark and *Flavesence doree* virus diseases of grapes.

STATES REGULATED: All

MATERIALS REGULATED: Grape plants and all parts capable of propagation, except fruit

RESTRICTIONS: Grape plants may be shipped provided they have been inspected and certified free of the viruses listed, by a state agency using an approved method.

PEAR ROOT STOCK AND SEED CERTIFICATION

STATES REGULATED: All

MATERIALS REGULATED: Pear root stock and seed (*Pyrus* sp.)

RESTRICTIONS: Pear root stock and seed shipped into New York for propagation purposes shall include a statement listing the variety of pear. Oriental pear species are prohibited entry except for research purposes with written permission from the commissioner.

VEGETABLE PLANT CERTIFICATION

PEST: Insects and diseases affecting vegetable seedlings.

STATES REGULATED: All

MATERIALS REGULATED: Vegetable seedlings

RESTRICTIONS: Plants must be certified to have been grown under an official certification program or to have been inspected and found apparently free of injurious insects and diseases. All shipments must be plainly marked indicating the names and addresses of the grower and the shipper.

PINE SHOOT BEETLE CERTIFICATION

PEST: Pine Shoot Beetle, *Tomicus piniperda*

STATES REGULATED: IL, IN, MD, MI, OH, PA, WV

MATERIALS REGULATED: Christmas trees and nursery stock of pine (*Pinus* spp.); logs and lumber with bark attached of pine *Pinus* spp.; bark nuggets including bark chips of pine *Pinus* spp.; tree stumps of pine *Pinus* spp.

RESTRICTIONS: Regulated pine materials must be certified free from all life stages of Pine Shoot Beetle, *Tomicus piniperda*. All shipments must be plainly marked indicating names and addresses of grower and the shipper.
