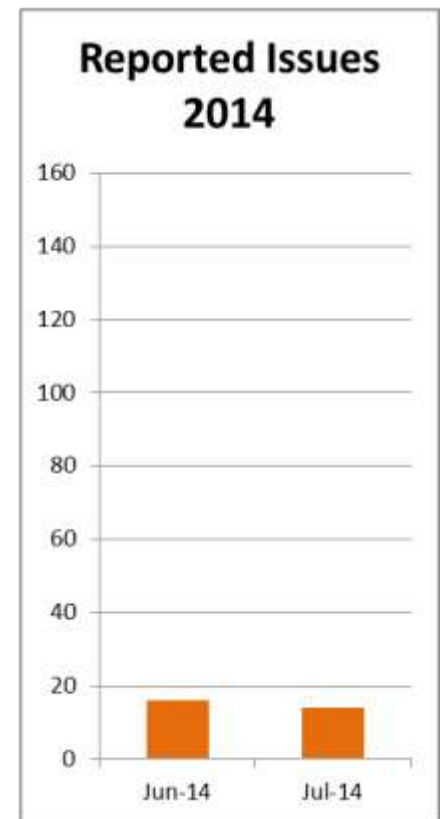
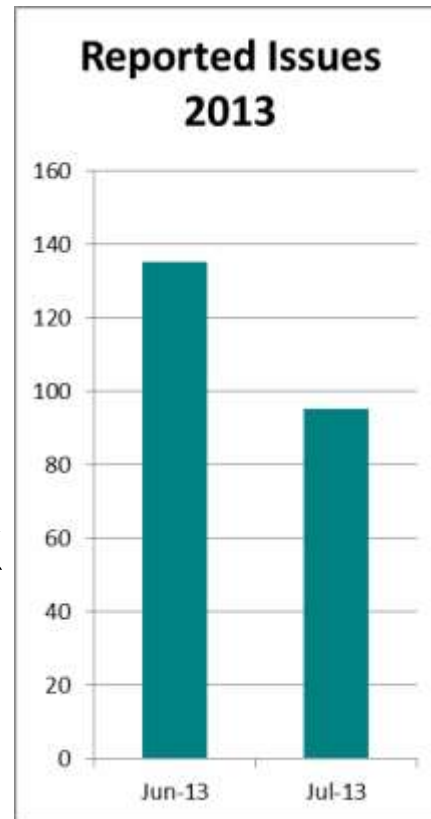

Turning IPHIS Around

Defining Priorities

- #1 – make uploads easier - system is of no value if you can't input data
- #2 –replace the mobile component
- #3 – make it easier to get info out of the system
– better reports & filters
- #4 – improve performance and utility of samples & lab modules

What we've accomplished

- New upload process released in early Feb.
 - 400 record limit removed
 - Upload, processing, & editing are separate steps

- **Site File**
Import multiple Sites into Existing Locations associated with a Work Book
- **Survey Activity File**
Import Survey Activities into Existing Sites (One Activity to a Site) associated with a Work Book. For each of the Survey Activities, import multiple Samples + Field IDs.
- **All in One File**
The same scenario as above (Survey Activity File), except New Locations and Sites will also need to be created. Address Books can also be created for the Location.

Feedback from the field


What would have taken 20 + hours was accomplished this morning in less than 2 hours.

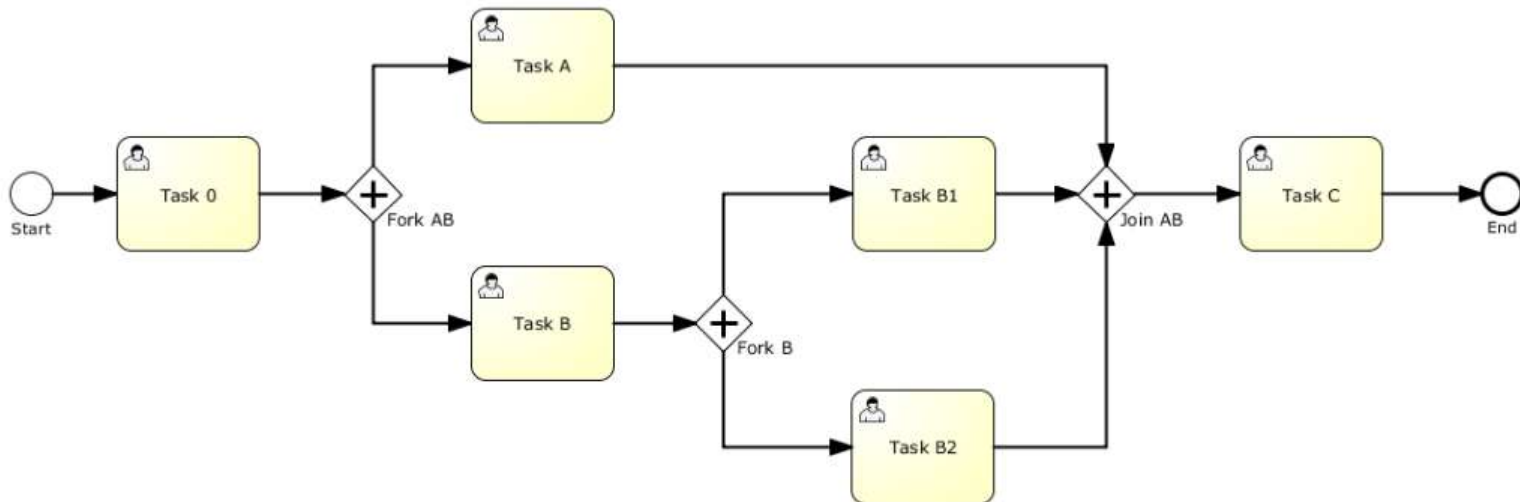

IPHIS 4.2 improvements

- Template Archiving
- Restored communication with PestID & EAN
- More filter options for Activities, Samples, & Lab modules
- Expandable filter boxes
- Exportable filters
- Improved pagination
- Optional display fields (show/hide columns)
- Samples module opens immediately
- Quicker response

Improvements in Progress

- Lab notifications
- Bulk determinations
- Automated forms (PPQ 391)
- Workflows – a series of tasks



Future

- Workflows - adding tasks to meet all pest program needs (ALB, FFD, . . .)
- Integrate with ARM
- Improve mapping and integrate with GIS
- Expand use of web services (app development & system to system transfers)
- Regulatory enhancements
- More report options for custom attributes
